(AbhayPratap Singh recounts his journey of awakening and gaining knowledge about the yeoman services that National Legal Services Authority has been playing to bring law within the reach of the common man and shape the future of dispute resolution in our country.)

s a student of law and also as a civil judge, my awareness about the National Legal Services Authority (NALSA) was rather limited and confined. It was until at a lecture organized by the Haryana State Legal Services Authority in Faridabad, where various schemes, plans and laws for the benefit of senior citizens in India were being contemplated upon. It was here that a speech by Hon'ble Justice Sh. Dipak Misra, Judge, Supreme Court of India and Executive Chairman, National Legal Services Authority (NALSA), touched me deeply and I realized the laudable role that PLVs have been playing in bringing law within the reach of the common man, shaping the future of dispute resolution in our country.

Thankfully, it is the vast network of 60,000 dedicated Para Legal Volunteers (PLV), socially responsive and committed

individuals like students, serving or retired teachers, retired government servants to mention a few who have vowed to bring justice to the doorsteps of the needy individuals. It is NALSA that will provide a panel of five-ten lawyers, for giving legal aid and counselling to any applicant at the 1000 first Common Services Centres (CSCs) to be built in Bihar and Uttar Pradesh.

Its remarkable that the 'National LokAdalats' being held bi-monthly by NALSA settled 5.32 lacs pre-litigation cases and 4.13 lacs pending cases organized on April 8, 2017. This adds up to a whopping 19 lakh pending and pre-litigation cases being settled through an alternate dispute resolution method. Hon'ble Justice Sh. DipakMisra has also initiated for picturisation and telecasting of 26 episodes of success stories at Doordarshan.

One of the recent, remarkable and distinctive contributions made by Hon'ble Justice Sh. DipakMisra was the inauguration of the 'Legal Assistance Establishment' (LAE) set up at Delhi SLSA, NyayaSanyog on May 17, 2017. LAEs make available multiple services by being the single point establishment for providing facilities to legal aid seekers under one roof and at a single location. These LAEs provide beneficiaries quick information about their case status pending in any of the districts.

Hon'ble Justice Sh. DipakMisra has undoubtedly given the legal world an invaluable legacy that shall never cease to encourage and guide force to all associated with the National Legal Services Authority.
